What is the High Risk Intervention Panel?

Nashville's High Risk Intervention Panel is a team of different agencies that discusses the highest risk cases of domestic violence and creates a plan of action in order to help increase victims' safety and hold offenders accountable.

Why is my case being reviewed by the High Risk Intervention Panel?

The police officer or advocate that served you was concerned about you and referred your case to the team. Reviewed cases include really dangerous risk factors and/or involve an offender who is very violent and capable of carrying out their threats.

What happens to my case during case review?

The team will review details of your case and discuss the best plan of action. This can include:

- a detective following up with you
- a counselor calling you to make a counseling appointment
- an advocate calling you about an Order of Protection or going into shelter
- a Victim Witness Coordinator calling you about what to expect in court
- a Probation or Parole officer filing a probation or parole violation

Our purpose is to try to increase your and your family's safety by providing as many services to you as possible.

When deciding on an action plan, we will always take your wishes into consideration. If there is something specific you would like the team to know about your case, let your advocate or officer know.

You can also come to the Family Safety Center (see reverse) to discuss your case and your options with an advocate, a detective, a counselor, or a District Attorney.
