### **BEST-PRACTICES IN VICTIM SERVICES**

### **Workshop Title: Confidentiality Best Practices**

**Workshop Description:** Over the last several years, there has been much discussion about HIPAA confidentiality requirements. You may not know that most victim services agencies have more stringent confidentiality requirements. This workshop will explore those requirements, the responsibilities of victim services staff, and confidentiality best practices for your work.

### **Objectives:**

- 1. Participants will gain an understanding of confidentiality requirements, including additional regulations specific to victim services agencies, to ensure compliance and mitigate legal risks.
- 2. Role Clarification: Participants will clarify their roles and responsibilities regarding confidentiality within victim services agencies, including proper handling of sensitive information and communication protocols.
- 3. Identifying Confidentiality Risks: Participants will learn to identify common confidentiality risks and vulnerabilities within their work environment, such as breaches of privacy and data security, and develop strategies to address them effectively.
- 4. Implementing Best Practices: Participants will acquire practical skills and strategies for maintaining confidentiality in their daily work, including confidentiality protocols, documentation practices, and effective communication strategies with clients and colleagues.

### **Workshop Title: Ethics in Victim Services**

**Workshop Description:** This workshop will explore several topics related to professional ethics for victim services providers, including professional boundaries, confidentiality, record keeping, acting within the scope of your profession, and more. This workshop will be highly interactive, with lots of time for questions and discussion.

This training presentation explores the fundamental ethical considerations within the realm of Victims' Services. Participants will delve into key pillars, including maintaining professional boundaries, safeguarding confidentiality, maintaining meticulous record-keeping practices, and operating within the defined scope of their profession. Through interactive discussions and case studies, attendees will gain insights into navigating complex ethical dilemmas, fostering trust, and upholding the highest standards of integrity in supporting victims of crime.

### **Objectives:**

### 1. Understanding Professional Boundaries and Confidentiality

 Participants will be able to define and explain the importance of maintaining professional boundaries and safeguarding confidentiality in victim services. • Attendees will learn to identify potential boundary issues and confidentiality breaches and understand strategies to prevent them.

### 2. Developing Effective Record-Keeping Practices

- Participants will learn the principles of meticulous record-keeping, including what information to document, how to document it, and the legal and ethical considerations involved.
- Attendees will be able to implement best practices for record-keeping that ensure accurate, secure, and confidential documentation.

# 3. Navigating Ethical Dilemmas and Scope of Practice

- Participants will explore common ethical dilemmas faced by victim services providers and develop strategies for resolving these dilemmas while maintaining professional integrity.
- Attendees will understand the importance of operating within the scope of their profession and the potential consequences of overstepping professional boundaries.

### Workshop Title: Effective Collaboration: Working with Interpreters in Victim Services

This workshop aims to equip victim service providers with the knowledge and skills necessary to collaborate effectively with interpreters. Participants will learn best practices for ensuring clear and accurate communication, maintaining confidentiality, and providing culturally sensitive support. Through interactive activities and discussions, attendees will develop strategies to enhance their work with interpreters, ultimately improving the services offered to non-English-speaking and Limited English Proficiency (LEP) clients.

# Workshop Title: Compassion Fatigue Part 1 - Revitalizing Compassion: Understanding and Addressing Compassion Fatigue in Victim Services

# **Workshop Description:**

This workshop is designed to help victim service providers differentiate between Compassion Fatigue and Vicarious Trauma and understand the unique causes and symptoms of each. Participants will explore the concept of Compassion Fatigue as a depletion of compassion, often resulting in emotional numbing to cope with clients' pain and distress. The session will emphasize that compassion is a renewable resource, offering strategies to replenish and sustain it. Through interactive discussions and practical exercises, attendees will learn how to recognize signs of Compassion Fatigue in themselves and others and implement effective self-care and resilience-building techniques.

### **Learning Objectives:**

### 1. Differentiate Between Compassion Fatigue and Vicarious Trauma:

 Participants will understand the distinct causes and manifestations of Compassion Fatigue and Vicarious Trauma, enabling them to accurately identify and address each condition.

## 2. Recognize and Assess Signs of Compassion Fatigue:

 Attendees will learn to identify the symptoms and early warning signs of Compassion Fatigue in themselves and their colleagues, fostering a proactive approach to self-awareness and peer support.

### 3. Implement Strategies to Renew Compassion:

 Participants will explore practical techniques and self-care strategies to replenish their compassion, maintain emotional well-being, and enhance their capacity to support clients effectively.

### **Objectives:**

### 1. Enhance Communication Skills for Difficult Conversations:

 Participants will learn effective communication techniques to approach challenging conversations confidently and clearly, including active listening, empathy, and assertiveness.

### 2. Develop Strategies for Emotional Regulation:

Staff members often absorb the traumatic stories of those they serve, potentially exhibiting similar trauma symptoms over time. This workshop delves into the importance of trauma-informed supervision, addressing how to make supervisory practices as trauma-informed as the work with victims. Participants will explore key questions, such as how to

support staff who are impacted by secondary trauma while maintaining a strong commitment to clients. Through interactive discussions and practical exercises, attendees will learn how traumainformed supervision can enhance staff effectiveness and productivity, fostering a healthier and more resilient workforce.

### **Learning Objectives:**

# 1. Understand Trauma-Informed Supervision Principles:

 Participants will learn the core principles of trauma-informed supervision, including recognizing the impact of secondary trauma on staff and integrating trauma-informed approaches into supervisory practices.

## **Learning Objectives:**

### 1. Identify Holiday-Related Stressors:

This training will explore the dynamics of domestic violence within family systems, the commonality of polyvictimization or co-occurring victimization within family units, how children are impacted by violence in their homes, and will briefly touch on how service providers can help to strengthen and promote healthy family relationships.

This course was designed to give the attendees an advanced understanding of the causes and risks associated with domestic violence, as well as offender profiles, barriers to safety and service for victims, how we can begin to change societal responses to domestic violence, and meet victims where they are to help them achieve their individual ideas of safety and justice.

The presentation will also cover how high-risk cases identified by the DA and the LAP are funneled into the HRIP and how the high-risk team works together to provide wrap-around services to survivors and accountability for offenders. # Workshop Title: When Trafficking hits Close to Home: Understanding the Dynamics of Intimate Partner & Familial Human Trafficking

**Workshop Description:** Human trafficking, domestic violence, child abuse, and sexual assault intersect in multiple ways, including methods of power and control, cycles of violence and continuums of abuse. These issues can be even more intertwined when an intimate partner or a family member engages directly in human trafficking, perpetrating against their own family member or intimate partner. Understanding the similarities within these crimes enables service providers, law enforcement, and prosecutors to identify and respond to intimate partner & familial human trafficking and integrate this work into domestic violence, sexual assault, and child abuse organizations, law enforcement units, and multidisciplinary teams with a thorough understanding of the intersections of these issues.

#### Familial specific:

Human trafficking by a family member is often missed by practitioners working with children and families due to a lack of information and understanding around this form of trafficking. However, familial human trafficking of children is a very common form of exploitation that can be recognized by providing a lens for exploitative abuse. Familial human trafficking also involves complex control structures and dynamics within families that are essential to understand in order to appropriately identify and respond to survivors of abuse. This session will explore these dynamics, the types of familial trafficking that can occur, and how to collaborate with a multidisciplinary team to respond to familial trafficking cases.

Multi-disciplinary teams were created to tackle the findings of the assessment and training and outreach efforts increased substantially. All of these changes came from the city taking responsibility for supporting victims and holding offenders accountable through the formation of the Metro Nashville Office of Family Safety. In this workshop, you will learn about Nashville's journey and key takeaways to develop your own innovative programming and practices throughout your city.

Strangulation is a high-risk abusive behavior that can seriously injure or kill a young person; however, there are multiple misconceptions around strangulation that have contributed to a lack of identification and even normalization of this dangerous crime. This training will explore the impact of strangulation perpetrated by family members or other trusted adults to children as well as the concerning trend with youth of strangulation within young dating relationships.

# Workshop Title: Implementing Trauma-Informed Care: How Understanding Trauma, Empowerment, & Wellness Strengthens Our Work

**Workshop Description:** Trauma-informed care acknowledges the need to understand a survivor's life experiences in order to deliver effective care, and has the potential to improve the experiences and outcomes of the people we serve. A comprehensive approach to trauma-informed care must be adopted at both the direct-services and organizational levels. Too frequently, providers attempt to implement trauma-informed care at the micro-level without the proper supports necessary for broad organizational culture change. This can lead to uneven, and often unsustainable, shifts in day-to-day operations. This narrow focus also fails to recognize how other staff, such as front desk workers and security personnel, often have significant interactions with clients and can be critical to ensuring that survivors feel safe. In this workshop,

we will be taking a look at trauma-informed work from multiple angles, across organizations and role to ensure implementation that can support both clients and staff.

#### **Objectives:**

- 1. Understand the foundational principles of trauma-informed care and their importance in improving outcomes for survivors of violence.
- 2. Identify strategies for implementing trauma-informed practices at both the micro (direct services) and macro (organizational) levels to foster sustainable cultural change.

This workshop explores innovative tools and strategies to create, implement, and enhance impactful training programs that engage your community and partner agencies, including local government, courts, and law enforcement. Participants will learn how to identify gaps in training, use technology to deliver accessible content, and strengthen cross-sector partnerships to improve outcomes for victims and survivors.

#### Workshop Title: Vexatious: How Abusers Use Our Systems Against their Victims

**Workshop Description:** Abusers often exploit the court system to maintain power and control over their current or former partners, engaging in tactics such as vexatious litigation, custody battles, and repeated filings. These actions can cause significant financial, emotional, and practical harm to victims, forcing them to navigate complex legal processes, often without support. This training will examine how abusers misuse the legal system, the impact on victims, and strategies professionals can use to mitigate harm and support survivors through these challenges.

#### **Learning Objectives**

- 1. Recognize Patterns of Legal System Abuse: Identify common tactics abusers use to manipulate the court system and the harmful impacts these actions have on victims' finances, employment, and emotional well-being.
- 2. Explore Legal and Advocacy Responses: Examine existing laws and tools designed to prevent vexatious litigation and discuss strategies for advocating for systemic changes to protect survivors.
- 3. Mitigate Harm and Support Survivors: Develop trauma-informed approaches and multidisciplinary responses to help victims navigate the legal system, reduce stress, and minimize the long-term consequences of court misuse.

Participants will gain practical tools to effectively support clients through the OP process, ensuring their experiences are accurately and powerfully represented.

- 1. Understand the Order of Protection Process: Navigate the procedural steps for filing an OP in Davidson County, from initial paperwork to court appearances.
- 2. Craft Clear and Compelling Narratives: Write strong, survivor-centered OP narratives that clearly document abuse, highlight risk factors, and align with legal requirements.
- 3. Support Clients Through the Process: Apply practical strategies to empower and guide survivors through the OP process, enhancing their confidence and chances of success in court.

# Workshop Title: Crafting Strong Orders of Protection: Hands-On Practice and Courtroom Application PRACTICUM

**Workshop Description:** In this interactive, hands-on session, participants will put their skills into practice by working through real-world case studies and mock scenarios. This workshop will provide advocates the opportunity to craft Order of Protection (OP) narratives for mock cases, receive feedback, and explore how their narratives might be presented and challenged in a courtroom setting. By engaging in this practical application, participants will deepen their understanding of writing effective OPs and gain confidence in supporting survivors through the court process.

Special attention will be given to considerations for victims in high-risk circumstances, including those facing escalating violence, stalking, or threats involving firearms. Attendees will leave equipped with trauma-informed approaches and tools to empower survivors in navigating their safety while addressing their unique needs and barriers.

# Workshop Title Intersections of Abuse: Understanding Co-Occurring Violence and Heightened Risk

This training will explore the interconnected dynamics of abuse, examine the heightened risks victims face in these situations, and provide strategies for identifying and addressing overlapping forms of violence. Participants will leave

with a deeper understanding of these intersections and practical tools to enhance their response to victims facing multiple forms of harm.

- 1. Identify the Intersections of Abuse: Recognize how domestic violence can co-occur with human trafficking, stalking, and child abuse, and understand the unique dynamics of these overlapping forms of violence.
- 2. Assess Heightened Risks to Victims: Analyze how co-occurring abuse increases a victim's risk of physical harm, emotional trauma, and lethality.
- 3. Develop Comprehensive Intervention Strategies: Apply trauma-informed and survivor-centered approaches to support victims facing multiple forms of abuse, ensuring safety planning and service delivery address their complex needs.

# Workshop Title Risk of Intimate Partner Violence in Pregnant and Postpartum Women: Understanding, Identifying, and Addressing Unique Challenges

**Workshop Description:** Pregnancy and the postpartum period bring unique challenges for women, and unfortunately, they can also increase the risk of intimate partner violence (IPV). This training will explore the elevated risks that pregnant and postpartum women face in abusive

relationships, the impact of IPV during this critical period, and strategies for identifying signs of abuse in expectant or new mothers. Participants will gain a deeper understanding of how IPV can affect maternal health, fetal development, and overall well-being, as well as learn effective ways to support survivors during this vulnerable time.

#### **Learning Objectives**

- 1. Identify the Increased Risk of IPV During Pregnancy and Postpartum: Understand the unique dynamics of intimate partner violence as it relates to pregnant and postpartum women, including physical and emotional risks.
- 2. Recognize the Signs and Impact of IPV on Maternal and Infant Health: Learn to identify indicators of abuse in expectant or new mothers and understand the potential effects of IPV on both maternal health and fetal development.
- 3. Develop Supportive and Trauma-Informed Approaches: Implement strategies to provide effective, compassionate, and trauma-informed care for pregnant and postpartum survivors of IPV, with a focus on safety, empowerment, and advocacy.

### Workshop Title: The Post-Roe South: Reproductive Coercion, Abortion, and Domestic Violence

Pregnancy is one of the most dangerous times for individuals in abusive relationships, particularly when there are existing patterns of reproductive coercion. This workshop will provide attendees with a comprehensive understanding of how reproductive control and coercion can trap individuals in abusive relationships, exacerbating the risks and challenges they face. Participants will be updated on the current state of abortion legislation in Tennessee and across the United States, with a focus on the recent changes following the reversal of Roe v. Wade. The workshop will place current legal statuses within the broader historical context of abortion in the U.S. Additionally, attendees will explore how present and future reproduction-focused legislation may impact victims of domestic violence and sexual abuse, considering both immediate and long-term effects.

- 1. **Understand the Dynamics of Reproductive Coercion**: Participants will learn to identify and understand the various forms of reproductive coercion and control, including how these tactics are used by abusers to maintain power and control over their victims.
- 2. **Analyze Current Abortion Legislation and Historical Context**: Participants will gain a thorough understanding of the current abortion laws in Tennessee and the United States, situating these within the historical context of abortion rights and restrictions in the country.
- 3. **Evaluate the Impact of Legislation on Domestic Violence Survivors**: Participants will assess the potential and actual impacts of current and future reproductive health legislation on victims of domestic violence and sexual abuse, discussing strategies for support and advocacy in this evolving legal landscape.
